Chesapeake Bay Cleanup Ideas Wanted

- Want to help clean up the Chesapeake Bay? Of course you do!
- Ever actively done anything to clean up the Chesapeake Bay? Maybe; maybe not.
- If you have done something to clean up the Chesapeake Bay, what did you do? Can others do it also?
- Please share your thoughts and good works with *The Old Man* and we will pass them on.

One innovative idea has received mention in the local press on a few occasions recently: floating fountains. These "aerators" are designed to restore oxygen to the water, which allows fish to survive, which brings in other aquatic life – turtles, crabs, grasses, sub-aquatic vegetation (SAV), and all the little creatures that live in the SAV. About two-dozen fountains have been anchored in Furnace Branch and Marley Creeks so far. The locals claim the fountains work. So does number one proponent, County Councilman John Grasso from Glen Burnie. His *Clean the Creeks* nonprofit is selling the fountains for about \$425 – or up to \$600 for the lighted versions. The fountains have about a 2-foot diameter floating base, are anchored to the bottom, and shoot a tower of water about 15 feet into the air – bringing oxygenated water back into the body of water. Since many MRSA members live where they could install the fountains, it may be worth a try. Personally, I like those false mussels that cleaned up the Magothy so well about 3 years ago, and oysters do a good cleaning job also. Unfortunately, false mussels and oysters are picky about habitat; fountains – not so picky.

So ... what have you done to clean up our Chesapeake Bay lately – or ever? Sharing is a virtue.

Dobbins Island Dispute Goes to Maryland High Court

Court of Appeals will weigh whether beach should remain available to the public

The article talks about a woman from Severna Park who has been going to the island in the Magothy River since the 1960s. "You'd picnic, meet people and swim," the Severna Park woman said of her trips to a beach that she and many others considered to be a public place." Then David and Diana Clickner bought the 7-acre island in 2004, with plans to make it their family home. Like most beach-front land owners on the river, they have no interest in hosting a summer long party or in sharing the beach with uninvited strangers who often leave their trash behind. So in 2006, the Clickners erected a modest low fence to mark their private property. But the Magothy River Association and others sued to keep the beach public, and won. The fence came down. The Clickners appealed, and the case is scheduled to be heard in Maryland's highest court. At issue is whether a century of tradition trumps private ownership.

"The judge has made my personal property a public park," David Clickner said in a recent interview. The Magothy River Association sees it differently. "Did somebody take something away from him, or is he taking something away from the public?" Unlike the Little Island or "Little Dutch" just north of the island, at least the Clickners ask for permits – unlike Mr. Wagner with his still un-permitted pool, rocks, lighthouse, and piers. Curiously, nobody parties on his island or ties up to his piers.

History: Baltimore Judge George Dobbins bought the island, also known to the locals at "Dutch Ship Island," in the mid-1800s as a retreat – when it was a larger place, and actually constructed buildings, long gone, on the island. The Magothy River Association says that the Dobbins family allowed public use of the beach and subsequent owners kept that tradition - or maybe just ignored the boaters who initially were rare since boats, especially power boats, were rare until the late 1950s on the river. In 1997, the Chesapeake Bay Magazine called the island a great stopping-off point for boaters, though it noted that "no trespassing" signs were posted "from time to time." (Once CB Mag publishes a quiet anchorage, it is that no more. - ED) The island was once home to Native Americans, and area residents say they used to find arrowheads when they explored there as children. Local lore has it that old Dutch coins, possibly from a shipwreck, washed ashore and that a Colonial-era ship's planks were found underwater nearby. Recently the sandy beach on the island's north side that has been the draw, serving as a destination for weekend boaters. Solitude has disappeared. The annual Bumper Bash, a daylong party that has drawn hundreds of boaters in recent years, is one example. The gathering of revelers has turned rowdy in the past, and the police presence has been stepped up.

Paul Spadaro, president of the Magothy River Association, says Dobbins Island plays an important role in the community as what he asserts is "the only public beach" in the Magothy. He said the Clickners *should have known* when they bought Dobbins Island from Jim and Edward Wilson for about \$825,000 that they purchased what amounted to a park. In fact, Spadaro wants to see the entire island turned into a public space, but his efforts to find a buyer willing to turn it into a park have been unsuccessful. A few years before, the owner was offering the land for \$1.00, but legalese and liability issues turned potential buyers away. Now what's at stake is the 1,200-foot sliver of beach. Under Maryland law, the public has access to any waterfront — the portion of land below mean high tide. Boaters can legally drop anchor along Dobbins' beach or tie up to the posts that remain from the Clickners' fence.

Mr. Clickner says he has no problem with the boaters but is not prepared to share the entire beach. "We can't manage a public park," he said. He mentions problems with underage drinkers, visitors who damage island foliage and the mess that many partiers leave behind. "We have picked up everything from beer cans to diapers to a lot of drug paraphernalia," Clickner said. "It's on our property, and if somebody gets stuck by a needle that has some kind of a virus in it, who are they going to sue?"

But if the Maryland Court of Appeals agrees with the lower court that the entire beach must be considered public land, it would set a precedent. After all, the Clickners pay taxes and insurance for their land, not the state. Similar efforts have been successful elsewhere. Florida and Oregon are among the states in which judges have ruled that past public use of private beach property created a custom that could continue over property owners' objections. The Florida case applied to just one location, but the ruling in Oregon applies to the entire coastline. The Maryland Supreme Court has been asked to settle the issue, which some legal experts say amounts to government granting the public free use of personal property without compensating landowners.


